KOC Conducts Fifth Preparatory Meeting for the Kuwait Oil & Gas Show (KOGS)

The Higher Executive Committee for the 5th Kuwait Oil & Gas Show and Conference (KOGS 2026) held its fifth coordination meeting as part of the preparations for the event, which will be hosted by KOC in February 2026.
